A resolution of the Wasilla City Council supporting a State Recreation Trail Grant application for Lake Lucile Park by the Wasilla Soil and Water Conservation District.

WHEREAS, the State of Alaska is making a solicitation for 2014 grant proposals through its Recreation Trail Grant program; and

WHEREAS, the Wasilla Soil and Water Conservation District is proposing to improve the trail system within Lake Lucile Park with grant funding from this program; and

WHEREAS, the Recreation Trail Grant program may provide grant funding up to \$50,000 for trail projects where a 20 percent match is required; and

WHEREAS, the 20 percent match is proposed through a combination of labor and equipment provided by the Wasilla Soil and Water Conservation District and the City of Wasilla.

NOW, THEREFORE, BE IT RESOLVED by the Wasilla City Council, that it supports a 2014 Recreational Trail Grant application by the Wasilla Soil and Water Conservation for trail improvements within Lake Lucile Park.

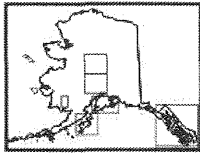

Summary Statement: The Wasilla Soil and Water Conservation District is proposing to submit a grant application for trail improvements in Lake Lucile Park through the State of Alaska Recreation Trail Grant Program. The grant program may provide up to \$50,000 in funding with a 20 percent match required. The match in this case is \$12,500 for a total project cost of \$62,500 where the match is proposed through a combination of labor and equipment provided by the Wasilla Soil and Water Conservation District and City of Wasilla. The City's share of the match will be provided with capital and operating funds already designated for Lake Lucile Park if the grant is awarded.
