This is necessary to complete the funding required by passage of AM 14-40 "Awarding a three (3) year contract to Premier Janitorial Services in the amount of \$82,182 for Janitorial Services at the Wasilla Public Library and Dorothy G. Page Museum".

The FY2015 janitorial cleaning contract requires \$14,400 for janitorial services to June 30, 2014 plus \$320 for deep carpet cleaning.
