This additionally will provide continuity and efficiency of having one Building Support Lead supervising two Building Support Laborers.

NOW, THEREFORE, BE IT RESOLVED, that the Wasilla City Council authorizes the elimination of one Building Support Lead position and adding one Building Support Laborer position and amend funding associated to this restructure.

Due to the current staffing changes at the Menard Sports Center, I would like you to consider the possible restructure of staff outlined below.

Currently, we have two Building Support Lead positions (one recently vacated) supervising one Building Support Laborer (recently vacated). We also have a Building Support Specialist whose sole respnonsibility is Mechanical Maintenance. The Specialist is not supervised by either Building Support Lead positions, as he reports directly to the Building Supervisor and Events Coordinator as well as the Deputy Director for Public Works.

After careful consideration, it is apparent the Menard Center only needs one Building Support Lead position. At this time, I am asking for the following consideration in staffing for the Menard Sports Center:

- 1. Eliminate one Building Support Lead position
- 2. Replace with one Building Support Laborer position

This change will provide continuity and efficiency of having one Building Support Lead supervising two Support Laborers. This will reduce payroll costs without sacrificing service to our customers and user groups or maintenance of the facility.
