Summary Statement: Wasilla Police Department (WPD), General Investigation Division (GID) currently has no funds remaining in its FY2015 budget to cover medical exams and other professional service expenditures. GID is incurring approximately \$1,550 per month in medical exams, particularly SART exams (of which a portion is reimbursable from the State of Alaska) and \$100 per month in other professional services.

WPD Patrol Division has \$5,000 available from its FY2015 original budget for medical exams in its Professional Services/Other line item.

Therefore, WPD wishes to transfer the excess from Patrol, Professional Services/Other line item to cover anticipated expenditures in GID.

The State of Alaska currently reimburses the WPD for SART exams; however, the revenue line item wasn't budgeted for in FY2015.

Therefore, WPD wishes to appropriate the estimated \$15,000 in medical exam reimbursements from the State of Alaska to the GID Medical Service Reimbursement line item.
