## **SUMMARY STATEMENT:**

Two library staff members, Karen Davis and Margaret Rogers, attended cataloging training in Fairbanks. The training was provided as part of an Alaska State Interlibrary Cooperative grant held by the Alaska Library Association Cataloging Round Table; expenses, including airfare, are reimbursable by the grant. The City purchased the plane tickets for Ms. Davis and Ms. Rogers to attend the training and these monies are to reimburse the City for that cost.
