SUMMARY STATEMENT:

The library applied for a \$7,000 Public Library Assistance Grant from the Alaska State Library. As the grant line item in the State Library's budget has not been fully funded for a number of years, and the money appropriated is not sufficient to fully fund the grants, regulations require that the State Library reduce each grant proportionally. As a result, the library has been awarded a grant in the amount of \$6,350 for FY09, which will be spent on book and audiovisual materials for the library.
