SUMMARY STATEMENT: Acceptance and appropriation of funds in the amount of \$9,955 received from AHSO for Operation Glow—an educational and traffic safety program held on Halloween Night. The program involves the distribution of lanyards and glow sticks to children prior to and on Halloween night.

Mat-Su Youth Court members will be attaching the glow sticks to the lanyards. Lanyards and glow sticks will be distributed to elementary schools throughout the Valley. The lanyards will have the logos of all Valley law enforcement agencies, the Mat-Su Borough School District, AHSO, and the Mat-Su Youth Court. Two Wasilla officers are scheduled to work overtime during a 4-hour time block in evening of Halloween to increase enforcement of traffic safety for both pedestrians and vehicles.

Wasilla PD has a strong commitment to highway safety and enjoys a positive working relationship with the AHSO. Operation Glow has been very successful in the Fairbanks area over the last few years, and the AHSO feels Wasilla PD is the appropriate agency to implement it in the Valley.
