AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING THE FY-09 POLICE DEPARTMENT BUDGET BY ACCEPTING AND APPROPRIATING FUNDS FROM THE STATE OF ALASKA DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES HIGHWAY SAFETY OFFICE IN THE AMOUNT OF \$3,079 FOR DRUG RECOGNITION EXPERT (DRE) PROGRAM.

SUMMARY STATEMENT: Acceptance and appropriation of funds in the amount of \$3,079 received from the State of Alaska Department of Transportation and Public Facilities Highway Safety Office to be used for the Drug Recognition Expert (DRE) program. AHSO will reimburse the City for travel expenses for the department's two DRE certified officers to attend the annual DRE conference in Indianapolis, Indiana. The conference focuses on drugs, alcohol, and impaired driving and the best practices in combating those issues.

Wasilla PD has a strong commitment to highway safety and enjoys a positive working relationship with the AHSO. The department's two DREs have been recognized as leading the state in promoting the use of DRE evaluation to investigate impaired driving.

Staff Recommendation:

Amend the FY09 police department budget to accept and appropriate funds from AHSO for the DRE program.
