A. Commissioner Barrett led the Pledge of Allegiance.

GENERAL CONSENT: The agenda was approved as presented.

B. City Public Works Director

Mr. Giddings stated that there has been an addendum on the bid for the library and the deadline date for submittals has been moved to February 25, 2015.

Mr. Payne stated that the City Council tabled the sale of the Meta Rose Square indefinitely, the land swap between the Church of Nazarene and the City is still on hold until the Alaska Supreme Court makes a decision, and he is a property owner that's within the Downtown Overlay District.

- Resolution Serial No. 15-03: Recommending that the Wasilla City Council amend Title 16 of the Wasilla Municipal Code to add Section 16.20.040, Downtown Overlay District, that establishes a downtown overlay district and adopts design standards for development and redevelopment on properties within the downtown overlay district.

Ms. Crawford provided the purpose and background for the Downtown Overlay District (Resolution Serial No. 15-03) and gave reasons and benefits of the overlay rules and regulations.

Mr. Kerry Wright stated that he is concerned about restrictions within the downtown overlay district and provided suggestions to change the overlay district boundary to exclude property on the Parks Highway and Main Street.

Ms. Marilyn McGuire stated that she was the former Mayor and believes this is a good idea but she stated her concerns about parking for people with mobility issues and during inclement weather.

Discussion moved to the Commission.

Mr. John Klapperich stated that he is in favor of the downtown overlay district and is on the Borough Planning Commission. He also stated that he would like to have a Commissioner from the City attend the Borough Planning Commission meetings so the City and the Borough can be more informed of projects happening within the City or Borough.

With no other comments, Chair Ledford closed the public hearing.
