**AN ORDINANCE OF THE WASILLA CITY COUNCIL TO AMEND THE FY-09 POLICE DEPARTMENT BUDGET BY APPROPRIATING FROM THE STATE OF ALASKA DEPARTMENT OF TRANSPORTATION FUNDS IN AN AMOUNT UP TO \$50,000 FOR CONSTRUCTION ZONE ENFORCEMENT.**

**Section 1. Classification.** This is a non-code ordinance.

**Section 2. Purpose.** To amend the FY-09 Police Department budget by appropriating up to \$50,000 from the State of Alaska Department of Transportation to be applied to the police patrol overtime pay for construction zone enforcement.

**Section 3. Appropriation.** Funds are appropriated to the following funds:


Overtime Expense: 001-4230-420.10-31 \$50,000

**Section 4. Source of Funds.**

Construction Zone Enforcement: 001-4200-334.10-12 \$50,000

**Section 5. Effective Date.** This ordinance shall take effect upon adoption by the Wasilla City Council.

**SUMMARY STATEMENT:** The City of Wasilla Police Department wishes to amend the FY-09 Police Department budget by approximately \$50,000, increasing the patrol overtime budget for Construction Zone Enforcement based on funding from the State of Alaska Department of Transportation (ADOT/PF). ADOT/PF has several road construction sites within the City and has set aside \$50,000 in the projects to pay for work zone enforcement by Wasilla Police Department. Because the overtime is reimbursed at actual cost, the exact appropriation is not known and the cap at \$50,000 is being used for the appropriation by Council.
