**SUMMARY STATEMENT:** These two donations are an annual integral part of the Clean-up Days and Arbor Days programs. WalMart annually makes a contribution to the city for the primary purpose of purchasing prizes for participants in the Clean-up Days program. In the past WalMart has provided an in-store voucher to use for the purchases. This year they awarded a check from their foundation for the same purpose. The Frontiersman has been a major sponsor of the Arbor Day Celebration for at least the last four years. Their donation enables the city to purchase a \$1,000 savings bond for the Arbor Day Poster Contest that is awarded to a fifth grade student from one of the local elementary schools. This ordinance accepts and appropriates the \$1,500 donation.
