## City of Wasilla Ordinance Serial No. 15-13

**Section 1. Classification.** This ordinance is of a general and permanent nature and shall become part of the city code.

**Section 2. Amendment of subsection.** WMC 1.20.030, Disposition of Scheduled Offenses—Fine Schedule, is hereby amended to update the fines for marijuana manufacturing as follows:

Summary Statement: Please see attached Ordinance Serial No. 15-13, which updates the fine schedule in Chapter 1.20 of the City Code. After Ordinance Serial No. 15-10(AM) was adopted on March 23, 2015, we discovered that WMC 1.20.030, Disposition—Scheduled Offenses should also have been amended to give marijuana manufacturing two different categories in the fine schedule.

In reviewing this section further and after discussions with the Chief Belden, it is also recommended to increase the fine for transport of marijuana.

**Staff Recommendation:** Introduce and set for public hearing Ordinance Serial No. 15-13.
