Section 3. Appropriation.



SUMMARY STATEMENT: The Matanuska-Susitna Borough School District has issued a grant to Mat-Su Youth Court in the amount of \$5,830. This will pay for personnel services in support of facilitation of the Minor Consuming Diversion Panel Class, the Juvenile Anti-Shoplifting Class and the Violence Reduction Class in the amount of \$4,830. The remaining balance of \$1,000 will be applied toward supplies for these classes.
