SUMMARY STATEMENT: This ordinance reduces revenue and expenditure accounts by \$230,000 in Matanuska-Susitna Borough funding for Lucille Street Improvements. This funding was originally appropriated in 2007 to be added to the City's federal funding for Lucille Street Improvements. The combined funding was to be utilized under a single engineering contract. The City has been unable to proceed using the federal funding. Therefore, the Borough is proceeding through a separate contract to make intersection improvements at Lucille Street and Seldon Road with their funding.

RECOMMENDED ACTION: To adopt Ordinance Serial No. 08-07 that amends the FY08 budget by reducing Matanuska-Susitna Borough funding for Lucille Street improvements in the amount of \$230,000.
