**CITY OF WASILLA
ORDINANCE SERIAL NO. 08-06**

**AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WMC 13.08.030,
USE OF PUBLIC SEWER REQUIRED, TO PROVIDE FOR EXEMPTIONS TO
REQUIRED CONNECTIONS.**

* **Section 1. Classification.** This ordinance is of a general and permanent nature and shall become part of the city code.

* **Section 2. Amendment of section.** WMC 13.08.030, Use of Public Sewer Required, is amended to read as follows:

A. **Connection to city sewer system required.**

1. **Except as provided in paragraph 2 of this subsection, t[T]he wastewater plumbing of any structure constructed after March 1, 1989, must be connected to the city public sewer system in accordance with the provisions of this chapter if the distance from the lot on which [UNLESS] the structure is located to any portion of the sewer system is not more than one hundred fifty (150) feet [FROM ANY PORTION OF THE SEWER SYSTEM AS] measured in a straight line [FROM THE SEWER SYSTEM PIPING TO THE NEAREST EXTERIOR LOT LINE ON WHICH THE STRUCTURE IS LOCATED].**


2. **A building need not be connected to the city public sewer system if either (i) construction of a main line extension is required to provide sewer service to the building, or (ii) the city sewer system does not have sufficient capacity to provide service to the building.**

B. A building that is not required to connect to [WHERE] the city public sewer system [IS NOT AVAILABLE] under the provisions of subsection A of this section[, THE BUILDING SEWER] shall be connected to a private wastewater disposal system complying with the subsurface sewage disposal provisions of the state of Alaska, Department of Environmental Conservation.

* **Section 3. Effective date.** This ordinance shall take effect upon adoption of the Wasilla City Council.

ADOPTED by the Wasilla City Council on January 28, 2008.

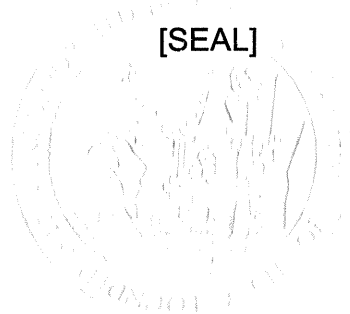





SUMMARY STATEMENT: This ordinance provides exemptions to required connections when a main line extension is required to receive service or if sufficient capacity does not exist within the city public sewer system. This ordinance is intended to provide relief for private property owners who cannot afford a main line extension to receive service when their property is located near the public sewer system. It also provides for an exemption when insufficient capacity exists in the sewer system.

RECOMMENDED ACTION: To adopt Ordinance Serial No. 08-06 that amends WMC 13.08.030, Use of Public Sewer Required, to provide for exemptions to required connections.
