SUMMARY STATEMENT: During the FY2008 audit of the City of Wasilla's financial statements, the auditors of Mikunda Cottrell & Co., Inc. recommended closing Fund 560 "Sewer Improvement Debt Service Fund".

This Debt Service Fund was originally set up to account for debt payments and collections of various Sewer Improvement Districts, such as the 1988 Overlook and 86S1 projects. These projects are and have been completed and closed. The funds remaining are an accumulation of payments that immediately followed the final debt payment and interest earnings on the fund balance from year to year.

It is the Finance Departments recommendation to approve this Ordinance resulting in the closing of the Sewer Improvement Debt Service Fund, Fund 560 and transfer the excess earnings to the Capital Reserve Fund to be used by future capital projects deemed necessary by Council.
