WHEREAS, the Canvass Board of the City of Wasilla met on October 7, and 9, 2015, and tallied the votes of Early, Absentee-by Mail, Questioned, and Special Needs ballots cast by voters; and

NOW, THEREFORE, BE IT RESOLVED, by the Wasilla City Council, that the October 6, 2015, Regular City of Wasilla Election was held valid to the best of our knowledge; and

BE IT FURTHER RESOLVED, that the results are certified as follows:

1. That David S. Wilson was elected to Seat A, a three-year term ending October 2018, having received the greatest number of votes cast for Seat A.

2. That Tim Burney was elected to Seat B, a three-year term ending October 2018, having received the greatest number of votes cast for Seat B.

3. Proposition No. W-1 to Maintain the Sales Tax Rate at 3%, failed to be adopted by the voters; *Shall the rate of the City of Wasilla sales tax remain three percent (3.0%), instead of decreasing to two percent (2.0%), after the sum of \$15,000,000 has been raised from sales tax and other sources to fund the construction and equipping of the new Wasilla Public Library? (Ordinance Serial No. 15-20).*
