Summary Statement: This resolution is part of the administration's annual effort to secure state funding for City capital projects, operating costs and other state priorities.

Mat-Su Youth Court Operating Funds

The Mat-Su Youth Court is a state-sanctioned court that operates in the Matanuska-Susitna Valley, Alaska, which deals with first-time juvenile offenders that have committed misdemeanors. A three-judge panel hands down sentences consisting of community work service hours, an essay, and other sanctions, such as a letter of apology, viewing an adult arraignment, a tour of the Mat-Su Pretrial Facility, a drug/alcohol assessment, or a Juvenile Anti-Shoplifting class.

Apron and Runway Expansion

This project will expand the apron area north and east along taxiway B to provide space for 30 additional aircraft tie-down spaces and 2 more lease lots. The airport's tie-down spaces are currently full and additional space is available for new apron area north and east as defined in the Airport Master Plan. This project will also generate fill material for phase one of the runway extension to 5,000 feet.

Gravel Road Paving

This funding will continue the City's program to pave the remaining gravel roads within the city limits. There are approximately 15 miles of unpaved gravel roads in the city limits and approximately 3 miles of gravel road can be paved for \$1 million.

State Land Transfer

This land transfer is being requested from the State of Alaska to support improved access to the Wasilla Little League Fields with a new driveway to Endeavor Street across the parcel; and to provide additional land behind Iditarod Headquarters in support of tourism.

Knik Goose Bay Road Improvements

This project is currently scheduled for construction in fiscal year 2019 by the State of Alaska. The City administration sees this as a high priority as traffic volumes continue to grow and new schools are opening in the area; and the administration believes this project needs to be advance as soon as possible.

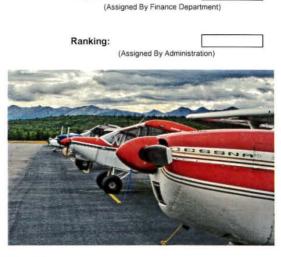

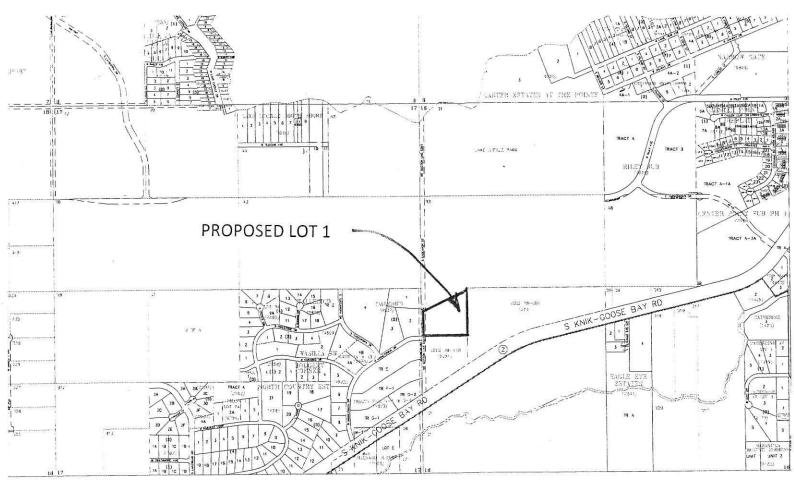

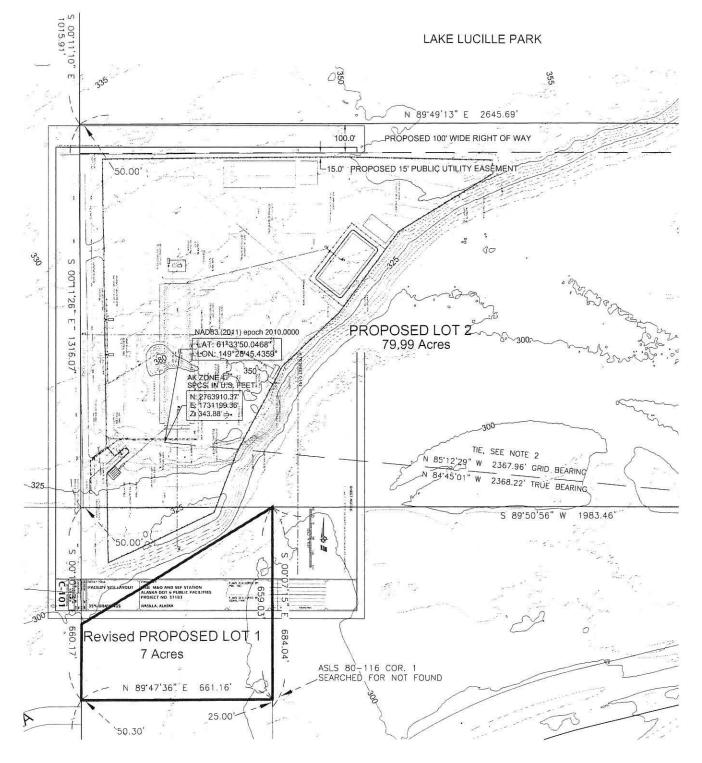

PROPOSED LOT 1

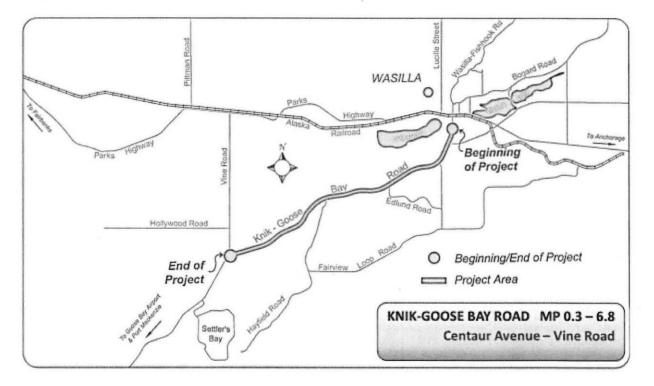


Knik Goose Bay Road: Centaur Ave. to Vine Rd.

Project Overview

The Alaska Department of Transportation and Public Facilities (ADOT&PF) is proposing to reconstruct Knik Goose Bay (KGB) Road in Wasilla from MP 0.3 (Centaur Avenue near the Palmer-Wasilla Highway intersection) to Vine Road at Mile 6.8. The goal of the project is to improve mobility for people and freight and to enhance access management along this segment of the road, thereby improving safety and reducing congestion for roadway users.

The project is currently in the environmental phase. After extensive public outreach and involvement, an Environmental Assessment (EA) has been prepared for the preferred alternative. The EA is now available for public review and comment. After environmental clearance is obtained, final design can begin.
