## V. UNFINISHED BUSINESS

A. **Joint Resolution Serial No. 06-01**: A Joint Resolution Of The City Of Houston, City Of Palmer And City Of Wasilla Supporting And Endorsing The State Of Alaska In Its Effort To Complete The Bogard/Seldon Road Extension East To The Glenn Highway And West To The Parks Highway Via King Arthur Drive.

MOTION: Council Member Mark Ewing, City of Wasilla, moved to adopt Joint Resolution Serial No. 06-01.

Discussion ensued regarding the merits of the resolution.

MOTION: Council Member Cox, City of Wasilla, moved a primary amendment to add the following language to the resolution: BE IT FURTHER RESOLVED that the Cities of Houston, Palmer and Wasilla recommend to upgrade distribution of delivery to a Class "A" felony with a presumptive sentence of five years for Methamphetamine related crimes.

Discussion followed regarding the proposed amendment.

GENERAL CONSENT: The primary amendment passed without objection.

Discussion continued.

GENERAL CONSENT: The main motion, as amended, passed without objection.

B. Update of Sales Tax Discussions with City Staff

Mr. Baugh reported on discussions held with the three cities regarding the contractor and home builder certificates that are being rewritten to make them less confusing and more convenient to obtain for the contractor and home builders. Staff will propose \$150 for a contractor and \$30 for a home builder to obtain a tax exempt certificate which would expire on December 31 of each calendar year.

Discussion followed and Mr. Baugh answered questions and concerns.

Council Member Fannon expressed that he will have to exit the meeting due to another commitment.

MOTION: Council Member Cox moved to enter into a work session format for the remaining items on the agenda. (Clerk's Note: This is due to the fact that a quorum of the meeting will not remain once Council Member Fannon exits the meeting.)
