A RESOLUTION OF THE WASILLA CITY COUNCIL ESTABLISHING LIBRARY CARD FEES FOR NON-BOROUGH RESIDENTS AND RECIPROCAL LIBRARY CARD HOLDERS AT THE WASILLA PUBLIC LIBRARY AND REPEALING RESOLUTION SERIAL NO. 05-06(SUB)

WHEREAS, the City of Wasilla Library would like to participate in the Alaska Libraries Reciprocal Borrowing Program which allows walk-in patrons with a valid library card from a participating Alaskan library to check out materials from any other participating library in the state; and

WHEREAS, more than fifty libraries in the state currently participate in the program including the Anchorage Public Libraries, the Fairbanks North Star Borough Public Library, the Juneau Public Library, the State Library, and the libraries at University of Alaska; and

WHEREAS, participating in the Alaska Libraries Reciprocal Borrowing Program will allow our patrons to checkout materials without having to pay for a library card from any of the participating libraries, including the Anchorage public libraries.

NOW, THEREFORE, BE IT RESOLVED, that the Wasilla City Council hereby approves the following amended fees for the issuing of non-borough library cards:

Reciprocal Library Card Holder (Limited Card):	No Charge
City or Borough Resident:	No Charge
Non-Borough Resident (annual):	\$35.00
Non-Borough Resident (3-month):	\$10.00

SUMMARY STATEMENT:

In 2005, the City Council passed a resolution to establish card fees for non-borough residents at the Wasilla Public Library. The fees established were \$35 for an annual card and \$10 for a 3-month temporary card. Since the passing of the resolution, the library has sold two \$35 annual cards and ten \$10 temporary cards for a total of \$170.

The City of Wasilla Public Library would like to participate in the Alaska Libraries Reciprocal Borrowing Program which allows walk-in patrons with a valid library card from an Alaskan participating library check out materials from any other participating Alaska library. More than fifty libraries in the state currently participate in the program including the Anchorage Public Libraries, the Fairbanks North Star Borough Public Library, the Juneau Public Library, the State Library, and the libraries at University of Alaska.

Joining this program will allow Wasilla Public Library's patrons to obtain an Anchorage Public Library card which allows them to check out three items at a time, for free. Otherwise, Anchorage charges non-borough residents whose libraries do not participate in the reciprocal program, \$10 for a three-month card or \$35 for an annual card. This is especially a very good benefit for our residents who commute to Anchorage on a regular basis.

STAFF RECOMMENDATION:

The staff recommends the repeal of Resolution Serial No. 05-06(SUB) and passage of Resolution Serial No. 08-42. These actions will allow the Wasilla Library to join the Alaska Libraries Reciprocal Borrowing Program and meet its condition of not charging patrons of participating libraries a fee.

WHEREAS, non-resident library card fees are common practice throughout Alaska and the Lower 48.

NOW THEREFORE BE IT RESOLVED that the Wasilla City Council hereby approves the following fees for the issuing of non-borough library cards:



SUMMARY STATEMENT: The Mat-Su Library Network (MSLN) is made up of representatives from the Wasilla, Palmer, and Mat-Su Libraries. This group consisting of librarians from each of the libraries have been working together to establish uniform policies for all phases of library operations. Most recently they have adopted a "Policy for Obtaining Library Cards" within the Mat-Su Library Network. Prior to this policy, non-borough residents (residents living outside the Mat-Su Borough boundaries) did not pay for using any of the Cities or Borough Libraries. Non-resident library card fees are common practice throughout the state and the Lower 48.

Recently, The Matanuska-Susitna Borough Assembly adopted the policy for residents and non-residents to obtain library cards. The following is the policy that was adopted:

Policy for Obtaining Library Cards in the MSLN

Purpose: To identify resident library card applicant procedures, and to address the increased use of MSLN public libraries by non Mat-Su Borough residents by setting up non-resident card fees.

Resident Library Cards: All permanent residents in the Mat-Su Borough are entitled to a library card free of charge. These library cards can be used at any public library in the Matanuska-Susitna Library Network Library.

To obtain a library card with full borrowing privileges, an applicant must first present a picture ID and proof of residency status in the Mat-Su Borough, along with verification of current mailing address.

The current mailing address will be verified by presenting a recent piece of canceled mail to the applicant's address or a post card can be provided to be mailed to applicant if no canceled mail is available.

Residency status can be verified with a current tax bill, utility bill, rental agreement, or a similar document for a location within the Mat-Su Borough.

Cards for children under the age of 18 will be issued only in the presence of and with the signature of a parent or legal guardian. The parent or guardian must meet the same requirements as any adult applicant.

Non-Resident Library Cards: Non-City and non-Mat-Su Borough residents may apply for a library card as follows:

All applicants must provide a picture ID, permanent mailing address information, and a local mailing address if possible. These cards are available to non-residents who regularly visit the Mat-Su Borough for an extended period of time.

Recommended fees for non-resident cards are:

\$35 annually for a full service library card with the same borrowing privileges as a resident card.

\$10 for a 3 month temporary card with the limited borrowing privileges of 3 items checked out at one time.

Exceptions to the non-resident card fees will be made to any person while an employee or volunteer for the Matanuska-Susitna Borough, City of Palmer, or the City of Wasilla, will have MSLN full borrowing privileges.

Any fees collected for these non-resident library cards will be considered revenue for the Wasilla Library and the City of Wasilla and will help offset operating expenses and are comparable to other public libraries in the state.
