SUMMARY STATEMENT: The City's continuation of new apron space is moving to 2010 since the City's need for new lease lots and tie-down spaces has been met with the completion of Apron Phase 1C. The next priority capital project for the airport is an expansion of the airport maintenance building or snow removal equipment building (SREB) with new snow removal equipment (SRE) planned in 2009. The SREB is proposed to proceed as a design/build project with an estimated cost of \$1.4 million.

Federal Aviation Administration grant requirements for design/build projects requires the airport sponsor to provide initial funding for engineering services (due to the low dollar amount) and include those costs in the grant application as part of the construction project. These funds will be reimbursed 95 percent by FAA later this year after the project is bid and a grant agreement is executed.

This resolution will provide the funding necessary to complete preliminary engineering and bidding of the project.

RECOMMENDED ACTION: To adopt Resolution Serial No. 08-10 that transfers funds within an accounting fund in the amount of \$52,850 for the Wasilla Airport Maintenance Building.
