### 1. CALL TO ORDER

The meeting of the Wasilla Parks and Recreation Commission was held Wednesday, December 10, 2008 at the Wasilla Multi-Use Sports Complex. Chairman Dave Tuttle called the meeting to order at 6:15 p. m.

Tedman Allen- new program at the Sports Complex for RC modeler airplanes that are 16oz or less and electric only. Flight night will be once a week for a couple of hours for customers to come out and fly their planes on the turf court area.

Bruce-currently working on the facility use permit for the kitchen which should be completed by the end of January.

Wal-Mart generously donated a 14 foot decorated Christmas Tree to the Sports Complex.

Dan Kennedy will possibly be coming to the next Park and Recreation meeting in January to ask for support in building a sports dome in the Valley.

The Sports Complex was featured in Serving the American Rinks Magazine that goes to many other ice rinks around the country.

Brandon Wall has been appointed to the Planning Commission and Mary K Randy-Robinson was appointed to the Parks and Recreation Commission. Joan Matthews was re-appointed on the Parks and Recreation Commission.

Colleen Sullivan-Leonard from the Governor's office has items that can be handed out at the celebration. Bruce will be out of town from December 24<sup>th</sup> thru January 6<sup>th</sup>, Tedman will be the point of contact. Commissioner Mary Shampine talked with the youth pastors at the Wasilla Assembly of God who would like to help with the

celebration. Commissioner Dave Tuttle will contact Henry from Matanuska Music to be a possible MC for the statehood celebration. Bruce will check with Archie to see if picnic tables can be moved over to the celebration area. Look into possibly playing some music for the celebration. Tedman will contact the school district for a possible phone announcement about the celebration. Bruce will place an ad for the celebration in the Frontiersman and the Anchorage Daily News with a provision if bad weather occurs event will take place the following weekend.
