WHEREAS, direct funding to 20 community councils across the Mat-Su Borough has provided a wide variety of locally important community needs such as emergency preparedness, safety, health and wellness, community council meeting place improvements and supplies, upgrades for parks, historic buildings, trails, and bridges.

NOW, THEREFORE, BE IT RESOLVED, that the Wasilla City Council requests the Alaska State Legislature fund the amount of \$60 million on an annual basis into the revenue sharing fund.
