

**Summary Statement:** Rodeo Alaska is seeking to hold a 3 day event at the Menard Center on May 27, 28 and 29, 2016. They are proposing to make this an annual event and they need an area of top soil for the rodeo events to take place on. Rodeo Alaska is proposing to bring in their own stands for seating to set up around the top soil area for the public to view the events.

The top soil mound at the Menard Center is proposed to be regraded to allow this event and other events to take place adjacent to the gravel area in the north parking lot. This work will expand the useable area outside for other events at the Menard Center.
