SUMMARY STATEMENT: Acceptance and appropriation of funds in an amount not to exceed \$57,444 from the State of Alaska Department of Public Safety (DPS) to be used for a police officer to participate in the Bureau of Highway Patrol (BHP) program.

DPS has received federal funding to create the BHP to address traffic safety concerns throughout the State of Alaska. The BHP is designed to partner with municipal police agencies to create regional traffic teams to perform specialized enforcement to focus on traffic safety issues. The teams will target problem areas identified by the BHP and municipal agencies, increase DUI patrols, work special events such as Iron Man and the Alaska State Fair, and respond to all serious injury and fatal collisions. The BHP has been patterned after the statewide drug enforcement task forces and is anticipated to be another successful partnership with municipal police agencies. Participation in this program will not only benefit the City of Wasilla but the entire Mat-Su Valley and allow coordination of highway safety enforcement activities with multiple law enforcement agencies in the South Central region of Alaska. The officer assigned to the BHP will be

provided a vehicle, office space, and specialized training in collision investigation and reconstruction. The BHP will reimburse all personnel costs and overtime for the participating officer. The initial costs to outfit an officer with personal equipment and weapons will be reimbursed in the first year.

The federal funding is anticipated to support the program for approximately 5 years with additional funding sources being identified each fiscal year.

Staff Recommendation:

Amend the FY09 police department budget to accept and appropriate funds from DPS to allow for participation in the BHP program and authorize the Chief of Police to execute a participation agreement with DPS.
