AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WMC 2.04.060(A), SPECIFICALLY TO MODIFY THE TIME COUNCIL MEETINGS WILL COMMENCE.

**Section 1.** Classification. This ordinance is of a general and permanent nature and shall become part of the city code.

**Section 2. Amendment of subsection.** WMC 2.04.060.A is hereby amended to read as follows:

A. Regular meetings of the council shall be held on the second and fourth Mondays of each month beginning at **six** [SEVEN] p.m. in the council chambers, unless otherwise designated by the council. The council may cancel a regular meeting, however, if no quorum exists. In an emergency, the mayor may cancel a regular meeting. No regular meeting shall be held on any holiday recognized by the city or on the fourth Monday of December.

Section 3. Effective date. This ordinance shall take effect November 1, 2009.

SUMMARY STATEMENT:				

In the past the Wasilla City Council has discussed the option of changing the starting time for regular Council meetings from 7 p.m. to 6 p.m.

When researching the starting times for meetings of other municipalities within the state, it was not uncommon for them to begin at 6 p.m.

A start time of 6 p.m. still allows time for commuters to attend Council meetings and for them to get home to their families at a reasonable hour.

Moving the time to 6 p.m. will save the City money by decreasing the amount of billable staff hours. As is known, lesser staff hours produces an increase in staff morale which in-turn increases employees effectiveness on the job.
