SUMMARY STATEMENT: Administration requests authorization from the Council	to
renew the City's contract with the City of Houston to provide animal control services	for
\$60,000. The City of Houston has provided animal control services to the City	of
Wasilla since 2003.	

**ACTION:** Council is requested to authorize the contract renewal for animal control services with the City of Houston for FY2009. Either party may terminate this agreement by giving 30 days written notice to the other party of termination.

Amendment adopted by Council at the June 23, 2008 Council Meeting: Contract approved, subject to Wasilla reviewing facility and operation and recommended improvements to same, which will be subject for negotiation of a contract amendment.

The City of Houston and the City of Wasilla agree to amend the Cooperative Services Agreement dated July 15, 2003, between the City of Houston and the City of Wasilla for Animal Care and Regulation Services as follows:

Section B (TERM) and Section J (PAYMENTS) shall be amended as follows:

#### B. TERM

The City of Houston and the City of Wasilla agree to amend the Cooperative Services Agreement between the City of Houston and the City of Wasilla for Animal Care and Regulation Services. Paragraph D of the Agreement shall be replaced with the following:

# D. <u>DEFENSE AND INDEMNIFICATION</u>

Wasilla shall indemnify, defend, and hold and save Houston, its elected and appointed officers, agents and employees, harmless from any and all claims, demands, suits or liability of any nature, kind or character, including costs, expenses and attorneys' fees which Houston may be subject to as a result of its performance of the services in this Agreement. This defense and indemnification responsibility includes claims alleging acts or omissions by Houston or its agents which are alleged to have contributed to a loss, failure, violation or damage. However, Wasilla shall not be responsible for any damages or claims arising from the sole negligence or willful misconduct of Houston, its agents or employees.

Wasilla agrees to name Houston and the Houston Department of Animal Control as additional insureds under Wasilla's General Liability and Errors and Omissions for Public Officials policies. Houston agrees to provide a workers' compensation policy for its employees, staff and volunteers and to have such coverage be in effect for services provided under this Agreement. Further, Houston agrees to name the City of Wasilla and its agents as additional insureds under any general liability policy carried by the City of Houston.

The parties acknowledge that they have read and understand the terms of this Amendment, have had the opportunity to review this Agreement with counsel, and are executing this Agreement knowingly and willingly.

#### A. PARTIES AND PURPOSE

#### 1. **Definitions**

In this agreement the following definitions apply:

- a. "ACO" means Houston's Animal Control Officer.
- b. "Animal Control Board" means Houston's Board of Animal Control and Regulation.
- c. "Animal license" means a license for a dog issued pursuant to the Wasilla code.
- d. "CACO" means Houston's Chief Animal Control Officer.
- e. "Cattery license" means a license to operate a cattery for five or more cats pursuant to the Wasilla code.
- f. "Enforcement" means any action taken by an ACO or the CACO under the Wasilla code.
- g. "Houston" means the City of Houston.
- h. "Kennel license" means a license to operate a dog kennel for five or more dogs pursuant to the Wasilla code.
- i. "Shelter" means Houston's facility located at Mile 57 of the Parks Hwy., or a kennel that is contracted by Houston for the interim housing of animals impounded by or surrendered to Wasilla or Houston
- j. "Wasilla" means the City of Wasilla.
- g. 'Wasilla code' means Chapter 7 of the Wasilla code of ordinances.

# 2. **Purpose**

Houston and Wasilla enter into this agreement pursuant to AS 29.35.010(13) to delegate to Houston the power to regulate animal care and control in Wasilla. This agreement provides for Wasilla to reimburse Houston for provision of these services as defined in "C. Scope of

Services." Wasilla delegates to the Houston Board of Animal Care and Regulation pursuant to Wasilla code Section 7.08.010 F the authority to exercise original jurisdiction for "vicious" animals and appellate jurisdiction in other matters. Wasilla will be represented by its attorney in animal care and regulation matters under this contract. This agreement will avoid duplication of services by having a single agency conducting animal regulation activities, housing animal shelter services at a central location, and creating a uniform system of hearings and appeals.

#### B. TERM

The term of this agreement shall be for one fiscal year beginning July 14, 2003 (a renewal for subsequent fiscal years shall begin on July 1st). The cost of services provided under this agreement shall be renegotiated on a yearly basis and shall be shall be implemented by a yearly budget addendum to this agreement.

#### C. SCOPE OF SERVICES

Houston will provide services to Wasilla under this agreement as described below.

#### **Field Officer Services:**

# Response-as-required services

CACO or ACO response services shall be provided 24 hours a day, seven days a week, at the request of Wasilla. Examples of responses include without limitation animal attacks, cruelty-to-animal allegation responses, unrestrained animals, police-requested animal intervention (i.e., pick-up animal secondary to a nuisance complaint), dead animal pick-up, etc. The issuing of warnings and citations is included with this service.

#### Animal incident investigation services

Services provided are the comprehensive, official investigation of animal-related incidents by the CACO or ACO for the purposes of documenting the facts surrounding an animal incident, discovering Wasilla code violations, issuing citations and direct interface with all parties concerned

#### Animal incident report services

Services provided are comprehensive written and electronic reports documenting all aspects of animal incidents in Wasilla. These reports will be provided to Wasilla on a monthly basis, and are primarily utilized to recommend the classification of animals and to provide information to the City of Wasilla as well as the Animal Control Board.

#### Kennel Licensing

This service includes initial and renewal licensing for kennels and all related inspection, documentation and reporting relative to issuing a kennel license.

#### Dead Animal Recovery

This service includes the removal of dead animals from public property in Wasilla (i.e., roadways, ditches, etc.). This service is included in the response-as-required normal hour services.

# **Animal Care and Shelter Services:**

This service category includes the care and shelter of animals on behalf of Wasilla for those animals that are impounded in Wasilla as a "stray," or that have been impounded by order of Wasilla and are neither retrieved by their owner nor adopted. As required by the Wasilla code, the shelter must retain animals without identification for a period not less than seventy- two (72) hours and animals with identification for not less than one hundred twenty (120) hours.

#### Animal intake

The intake of animals into the Houston shelter or kennel contracted by Houston includes: all paperwork and documentation of the animal, a preliminary physical exam for possible medical conditions, search for identification, search for vaccination history, attempt to contact owners in cases of stray animals, intake processing procedures and related paperwork, and assignment to kennel.

#### Animal emergency veterinary care

Services include engaging Houston's contract veterinarian for serious medical problems of the animal in the protective care of the shelter.

#### Animal housing and feeding

Services include housing the animal in a kennel that is maintained in a clean and sanitary condition. The animal is provided ample water, nutritious food, and is exercised regularly.

#### Anima! vaccination

Each animal sheltered will be provided with vaccinations if it is not current on required vaccinations.

#### Animal euthanasia

All animals that are not owner-claimed and/or not adopted from the Shelter within the time allowed by the Wasilla code are humanely euthanized.

#### **Routine Clerical**

All routine administrative and clerical functions are included in the Shelter Services. These services include data input, records maintenance, mailing letters, photocopying, etc.

#### **Large Animal Services:**

#### Field Officer Services

Services include ACO response to large animal incidents, investigation, issuing citation(s), etc. and is included in the response-as-needed category above.

#### **Animal Care & Regulation Board Services:**

#### **Animal Board Hearings**

The Wasilla code requires an appeal process for animal classification by the CACO. The Animal Control Board is charged with providing a non-biased, third- party forum to hear grievances on decisions made by the Houston Animal Control Officers.

#### **Brief writing**

The CACO must write a Brief providing Houston's position and related actions pertaining to an animal classification, and that Brief is submitted to the Houston Clerk's office for distribution to the Animal Control Board.

## Houston Clerk's office processing

The Houston Clerk's office coordinates and administers the Animal Control Board Hearings including scheduling, facilities, notifications, document reproduction and distribution, recording proceedings, transcriptions, etc.

#### Wasilla Attorney

Should Wasilla require legal representation for any purpose relating to the preparation and/or hearing/court appearance for matters concerning Animal Control issues, the Wasilla attorney will be used. Houston shall not be responsible for any attorney services related to infractions and the related prosecution expenses.

#### **Administrative Services:**

There are no charges to Wasilla for the administrative services described below:

#### **Invoicing**

The City of Wasilla will receive monthly invoices for services provided under this contract.

## **Activity Reports**

At least once a month, Wasilla will receive an activity report outlining Field Activities, number of hours of patrol, animal intake numbers, animal emergency veterinary care, animal housing and feeding, animal vaccination, etc.

#### Fine Collection

Houston will collect all fines and bail forfeitures that are payable for violations of the Wasilla code, and remit the amounts collected to Wasilla no less frequently than once a month.

#### D. DEFENSE AND INDEMNIFICATION

Wasilla shall indemnify, defend, and hold and save Houston, its elected and appointed officers, agents and employees, harmless from any and all claims, demands, suits, or liability of any nature, kind or character, including costs, expenses, and attorney fees which Houston may be subject to as a result of its performance of the services in this agreement. This defense and indemnification responsibility includes claims alleging acts or omissions by Houston or its agents which are alleged to have contributed to the losses, failure, violations, or damage. However, Wasilla shall not be responsible for any damages or claim arising from the sole negligence or willful misconduct of Houston, its agents, or employees.

Wasilla agrees to name Houston and the Houston department of Animal Control as additional insureds under Wasilla's General Liability and Errors and Omissions for Public Officials policies. Houston agrees to provide a workers' compensation policy for its employees, staff and volunteers and to have such coverage be in effect for services provided under this contract.

#### E. NON-DISCRIMINATION

In performing its duties and obligations under this Agreement, neither party may discriminate against any person on the basis of race, creed, color, religion, national origin, age, sex, status as a disabled veteran or a veteran of the Vietnam era, marital status or physical handicap.

#### F. AMENDMENTS TO THE AGREEMENT

The parties may, by mutual consent, modify or change terms in this agreement by written amendment. Any amendment shall be in writing and shall become a part of the agreement. Amendments which have a fiscal impact shall also modify the yearly budget addendum to this agreement.

#### G. TERMINATION

#### 1. Termination for Cause

If either party fails to fulfill its obligations, or if either party breaches any of the covenants, agreements, or stipulations of this contract, the other party may terminate this agreement by giving written notice of termination. The party in breach shall have 15 days to cure the breach. If the party fails to cure the breach within 15 days, the non-breaching party shall send a notice of termination by facsimile and registered mail. If Houston issues the termination notice, it shall state the number of Wasilla animals and pending cases and provide a deadline for Wasilla to remove the animals from the Houston animal shelter. If Wasilla issues the termination, it shall state when and how it will remove its animals from the Houston animal shelter and pending cases from Houston's jurisdiction.

# 2. <u>Termination for Convenience of the Parties</u>

Either party may terminate this agreement by giving 30 days written notice to the other party of termination. Upon termination, Houston will provide copies of all pending animal control case files to Wasilla. If there are Wasilla animals at the Houston shelter at the date of termination, Wasilla agrees to pay for the care and maintenance and other associated costs of the animals until the animals are transferred to another facility, adopted or returned to an owner.

#### H. CAUSES BEYOND CONTROL

If a party is prevented by a cause or causes beyond the control of the party from performing any obligation of this agreement, the party shall not be found to have breached this contract and shall not be liable for damages or for termination for cause. "Causes beyond control" means one or more of the following: fire, explosions, acts of domestic or foreign terrorism, severe weather conditions, acts of God, war, orders of law of duly constituted public authorities, and other major, uncontrollable and unavoidable events, which must actually prevent the party from performing the terms of this agreement.

#### I. ADMINISTRATION

The Mayor of Houston, or his or her designee, shall be the representative of Houston administering this agreement. The Mayor of Wasilla, or his or her designee, shall be the representative of Wasilla administering this agreement.

#### J. PAYMENTS

Wasilla shall pay the Houston \$26,000.00 for a fiscal year period from July 1<sup>st</sup>, through and including June 30<sup>th</sup> of the following year, for services rendered under this agreement. The first payment, in the amount of \$2,166.67, shall be due on July 14, 2003, and all subsequent payments shall be in the amount of \$2,166.67 and shall be due on the first of each month thereafter.

#### K. ASSIGNMENT

Neither party may assign an interest in this agreement or transfer any interest in this agreement without the prior written consent of the other party.

#### L. WAIVER

The failure of a party to enforce a provision of this agreement shall in no way constitute a waiver of the provision. The failure of a party to enforce a provision of this agreement shall not affect the validity of this agreement or any part of the agreement or the right of a party to enforce each and every provision of the agreement.

#### M. SEVERABILITY

If any section or clause of this agreement is held invalid by a court of competent jurisdiction, or is otherwise invalid under the law, the remainder of this agreement shall remain in full force and effect.

#### N. GOVERNING LAW

Any civil action arising from this agreement shall be brought in the superior court for the third judicial district of Alaska at Palmer. The law of the state of Alaska shall govern the rights and obligations of the parties.

# O. INTERPRETATION AND ENFORCEMENT

The parties have executed this agreement following negotiations between them. The parties agree that the agreement shall be construed according to the intent of the language in the document as a whole and not for or against any party. The rule of construction against the drafter shall not apply to this agreement. The titles of sections in this agreement are not to be construed as limitations or definitions, but are for identification purposes only.

# Q. ENTIRE AGREEMENT

This agreement and all appendices and amendments to it constitute the entire agreement between the parties. There are no promises, terms, conditions, or obligations other than those contained herein. This agreement shall supersede all previous communications, representations or agreements, either oral or written between the parties.

#### R. ACKNOWLEDGMENT

The parties acknowledge that they have read and understand the terms of this agreement, have had the opportunity to review the agreement with counsel, and are executing this agreement knowingly and willingly.

I am writing this letter in support of the Houston, Alaska Shelter. I have been working with the shelter for several years as the Founder of Chateau Pampered Purr, a 501 (c) non Profit rescue organization. I have taken into my facility from Houston approximately 200 adult cat and kittens. Chateau Pampered Purr placed into homes (201) cats in 2006, (197) cats 2007, and as of June 6th 2008 (88) cats have been placed. As I am sure you are aware the Shelter is small and the funds to run the Shelter are smaller. In a perfect world we would all have the best supplies and tools to do our work. and all pet owners would be responsible , spay, neuter and give a life long home to animals they acquire. That said I will tell you what I do know of the Shelter Staff and the Shelter. The animals are kept warm and Fed, the (SHELTER) accommodations may not be Five Star, but the living on the street hungry, cold, and lost would not be rated even One Star. Last week June 3, 2008 Evelyn Rohr drove into Anchorage Eleven cats to my shelter, one adult male, one pregnant female, one mother with four kittens, and two teens, the only cat left at the shelter was a very. old female that had just been dumped by the owners, and was still traumatized . the shelter wanted to give her a few days by herself to adjust. I have offered to rescue this cat, as It is unlikely that at her age she will be re - homed in the Valley. All of the cats were healthy, no cat Cold/Upper respiratory, and the cat that came to the Shelter with ear mites had been treated. I do not rescue cats from the Anchorage Shelter because of the Cat Cold/Upper respiratory, eye Herpes, Fip, virus's present in the shelter. Bigger is not better in this case, the larger shelters have the virus present in the ventilation systems, and the more employees working with and around the animals, the greater the chance is that you will have cross contamination. Fresh air flow is a major factor in preventing Cat Cold/ Upper respiratory virus in cats. as well as low stress levels. After twenty years of cat rescue, and \$120,000 thousands of dollars later in the treatment of Shelter rescues, I do consider my self knowledgeable. when I visited the Houston Shelter that the staff aired the area during the

cleaning process and when staff was there, this is very important for the prevention of air born virus control. I can not praise enough the compassion that this group gives and shows the Dogs and Cats that are in charged to the Shelter. I often ask how may cats have been put down and I am trusting in the answer given, only the ones that are Feral or have not turned around in a couple of weeks. I do know that the Shelter has had cats up for adoption for as long as a month or longer, prior to running out of space. I am asked if I can take the cats for placement as Anchorage has a larger adoptive home pool. Chief Dennis Lords and Officer Rick Molburg are truly compassionate in the care off the shelter animals and will do everything reasonable not to destroy, healthy, tame, non-aggressive, charges, Both on them have delivered cats to Palmer Vet Clinic and picked them up after spaying and neutering, prior to Evelyn Rohr transporting them to my Shelter, on personal time. I will be glad to answer any questions you may have or meet with you, my work number is 729-2964, the shelter 770-6425.

# Dear Mayor Keller,

My name is Evelyn Rohr and I have volunteered at the Houston shelter since it's inception.. I had the pleasure of meeting you when I came to vaccinate the St Bernard you adopted from us. I was forwarded a copy of the email that Linda Henning sent to the council members. After reading this over several times I am wondering if perhaps Ms Henning does not have an ulterior motive for being as negative as she was. She states that the funding for her dog news comes in part from the Mat-Su Shelter. If Ms Henning truly had the interest of the animals at heart, I would think that she would include our animals and not punish them for the fact that our shelter is not up to her standards.

I am at the shelter frequently and I would like to address some of the issues Ms Henning brought up.

- 1. Older Dalmatian running loose. This is Dillon who was found in Wasilla. He is at an age where he is essentially not adoptable, he has been on the web site since January 22<sup>nd</sup> of 2008 with no calls on him that resulted in his being adopted. Rather then putting him down, our staff decided to keep him as a shelter dog so that he can live out his remaining years. He is in the office most of the time, however when the weather is nice, he gets to wander occasionally. If any animals are arriving Dillon is put in a run until the intake is complete. He seems very happy with his life and at his age the danger of him running off is nil. He never wanders far from the door and is always under the observation of a staff member.
- 2. Open doors. We have been fortunate in not having airborne illnesses such as URI and Kennel cough in our facility. One of the reasons for this is the fact that rater than re-circulate stale air throughout the facility, whenever conditions allow, we open the doors to allow airing out of the facility. With Ms Henning's background as a veterinary assistant, I'm surprised that she does not understand that fresh air can aid in keeping a facility healthy. Our cat cages have

two closing mechanisms on them and even the most agile of cats have not been able to open them. The cages are smaller than I would like but they are clean and allow for maximum air circulation. It is unfortunate that Ms Henning did not visit the shelter on Tuesday. We had several beautiful friendly cats and four kittens that I drove into Chateau Pampered Purr in Anchorage for rescue. The older cat still at the shelter was a drop off after being in a home for 13 years so of course she was scared. I have arranged for her to be rescued also but want her to have a few days to adjust to her new situation. The other cat had just arrived at the shelter not more than a half hour prior to Ms Henning's visit.

- 3. Holes in the cages. This is a full time problem as most dogs do not like to be shut is a run. Repairs are made on a regular basis and if Ms Henning had taken the time for observation, she would have noticed the materials were on site and the repairs were ongoing.
- 4. Board with nails are not scattered around, the photo shows one board on the side of the building between a live trap and the building. This has been removed and had only been placed there earlier in the day. As far as dog feces, this is picked up on a regular basis but on any given day with a number of dogs it is impossible to keep up with the clean up completely. 5. Dogs chained inside runs. Every once in a while we will get a dog that is determined to claw its way through the chain link. For the protection of the dog, staff and visitors, these dogs are chained inside a run in order to prevent an escape.

Ms Henning for all her experience obviously has problems identifying her dog breeds. The dog Officer Molberg was bringing in was a very old pure bred long haired German Shepherd whose only ailment is old age. Any injured animals brought during business hours are taken to Palmer Vet and after hours to the vet on call.

We are continually looking for ways to improve our facility, however this takes time and money and we are gradually making improvements. I would rather work any day with a staff that has compassion, caring and the flexibility to hold on to adoptable animals until a home can be found, and in some cases give an older dog a warm comfortable home to live out its remaining days.

When I first came to Alaska I worked for West Anchorage veterinary Clinic and Jewell Lake boarding and grooming in Anchorage as a kennel and Veterinary assistant, and after moving to the Valley spent seven plus years working at Big lake Veterinary Hospital as a veterinary assistant.
