An Ordinance Of The Wasilla City Council Amending The Fiscal Year 2017 Budget By Appropriating \$18,000 From The General Fund, Fund Balance For Pedestrian Tunnel Lighting At Newcomb Park.

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. To transfer funds from the general fund for a capital improvement project at Newcomb Park to repair damaged lighting in the pedestrian tunnel.

Section 3. Appropriation of Funds. The funds are appropriated to the following:

Section 4. Source of Funds.



Summary Statement: This project is proposed to install new vandal resistant lighting in the pedestrian tunnel at Newcomb Park. Currently, all of the lighting has been damaged over time and a new lighting system is needed. The new lighting will be impact resistant LED fixtures that will have a product warranty against physical abuse at the cost of \$550 per fixture. 22 fixtures are needed at a cost of \$12,100 plus installation cost at approximately \$5,000.

Staff Recommendation: Adopt Ordinance Serial No. 16-27.

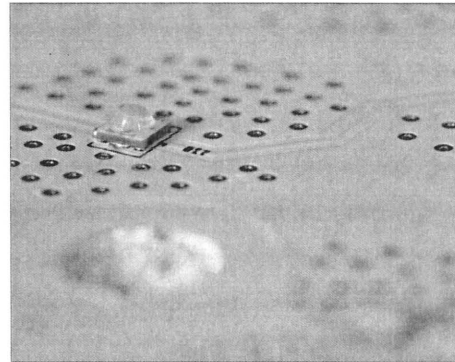

LED Product Warranty

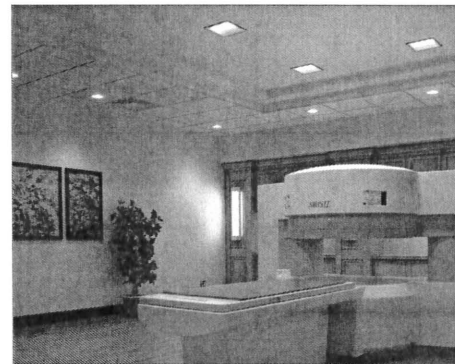
In addition to the standard product warranty, Kenall warrants LED lamps and internal power regulation components for a period of five years from the date of the invoice against defects in materials and workmanship that result in a fixture lumen depreciation of 30% or greater. Lumen depreciation is compared to the published lumen output of the product on the date of manufacture per IESNA LM-79-08 reporting procedures. Normal accumulation of particulates on the optical surfaces shall not be factored into the lumen depreciation.



Scansafe Guarantee™

Kenall will repair or replace any MRI LED product, for a period of one year, when installed according to our instructions, that fails to perform to applicable MRI room interference and susceptibility standards.

In addition, Kenall will repair or replace only LED products that fail to provide 70% of rated light output for five years from its date of installation.
