Summary Statement: Council Members Colleen Sullivan-Leonard, Seat D, and David Wilson, Seat A, have submitted letters of resignation from the Wasilla City Council effective December 13, 2016, due to their recent election to the Alaska State Legislature.

Pursuant to WMC 2.04.040, the Council shall declare a Council seat vacant when the person elected resigns and the resignation is accepted by the Council. Additionally, the vacancy must be filled by the Council within 45 days.

The appointment process below is consistent with past practice and recommended by the City Clerk.

Letter of Interest and Application:

- The City Clerk shall open the application period on December 13, at 8 a.m. and close it at noon on December 28.
- Interested persons shall file a completed application accompanied by a letter of interest with the Office of the City Clerk during the filing period only.

Interview Questions:

- Council Members may ask no more than two questions of each applicant.
- The question(s) are due in advance to the City Clerk by the close of business on Thursday, December 29.

Interviews:

- The City Council will interview the qualified applicants at its January 9, 2017, Regular City Council Meeting.
- Each applicant will be given 3-minutes to make an opening statement.
- Each Council Member, who submitted a question(s) to the City Clerk, will ask the question(s) during the interview.
- The questions asked of each applicant will be the same.
- The Council may ask a follow up or clarifying question, but should not veer too far from the original question asked.

Selection/Oath of Office:

- After the interviews have ended, the Council may enter into Executive Session to discuss the applicants, provided each applicant agrees to being discussed in Executive Session.
- In open session, a motion must be made to appoint an applicant to Seat A and then Seat D (one motion at a time).
- Once the motion is on the floor, the Council may enter into debate.
- Four affirmative votes are required to carry the motion.
- Those appointed will immediately take an oath of office, administered by the City Clerk, and take their seats at the dais.
- The appointees will remain in office until October 23, 2017, when those elected in the October 3, 2017, election, assume office.

Staff Recommendation:

- Accept the resignation of Council Members Colleen Sullivan-Leonard and David Wilson, effective December 13, 2016;
- Declare Council Seats A and D vacant, effective December 13, 2016; and
- Approve the appointment process as outlined above.
