On October 8, 2007, the Wasilla City Council passed Ordinance Serial No. 07-55(SUB)(AM) which granted funds to the Wasilla Area Seniors Inc. (WASI) in the amount of \$25,000.

CITY OF WASILLA ORDINANCE SERIAL NO. 07-55(SUB)(AM)

AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING THE FY-08 BUDGET BY TRANSFERRING \$25,000 FROM THE CITY COUNCIL'S BUDGET TO WASILLA AREA SENIORS, INC. IN ORDER TO CONTINUE TO PROVIDE SERVICES AND PROGRAMS TO RESIDENTS OF THE CITY OF WASILLA AND THE MATANUSKA-SUSITNA BOROUGH.

WHEREAS, Frank D. Smith donated land with the intent to provide Wasilla with an area where senior citizens could come and meet other seniors; and

WHEREAS, Wasilla Area Seniors, Inc. (WASI) is a non-profit organization that incorporated on June 16, 1981; and

WHEREAS, WASI is classified as a public charity under the Internal Revenue Code; and

WHEREAS, WASI provides approximately 1,700 hot meals each month for senior citizens who visit the Frank D. Smith Senior Center; and

WHEREAS, an additional 678 meals are delivered monthly to senior citizens who are confined to home; and

WHEREAS, WASI provides daily transportation to senior citizens needing to visit the doctor, do shopping or banking, and attend special events; and

WHEREAS, WASI manages 129 units of low-income senior housing, which includes 12 assisted living units; and

WHEREAS, WASI provides senior citizens with a safe environment for socialization, mental stimulation, and health improvement; and

WHEREAS, WASI is a community treasure that depends on grants, gifts, and donations to operate; and

WHEREAS, WASI serves as a Community Center for the entire Matanuska-Susitna Borough; and

WHEREAS, as a non-profit organization, funding support is vital in order for WASI to continue to provide services and programs to residents of the City of Wasilla and the Matanuska-Susitna Borough; and

WHEREAS, the funds granted from the City of Wasilla to WASI shall not be used for salaries and benefits; and

WHEREAS, the Wasilla City Council wishes to receive a report no later than January 1, 2008, regarding how WASI spent the funds granted; and

WHEREAS, if a report is not given, additional funding for WASI will not be considered in the FY09 and FY10 budget.

NOW THEREFORE BE IT ENACTED by the City of Wasilla:

- * Section 1. Classification. This is a non-code ordinance.
- * Section 2. Purpose. To transfer funds to the Wasilla Area Seniors, Inc.
- * Section 3. Appropriation. Funds are transferred to the following fund:

Wasilla Area Seniors Inc. Grant 001.4115.411.80.xx \$25,000

* Section 4. Source of Funds. Funds to be transferred from the City Council budget, from the following accounts, totaling \$25,000:

001.4115.411.30.30	Accounting/Auditing Services
001.4115.411.30.32	Legal
001.4115.411.30.34	Other Professional Fees
001.4115.411.50.81	Travel

* Section 5. Effective date. This ordinance shall take effect upon adoption of the Wasilla City Council.
