SUMMARY STATEMENT: In the FY2009 operating budget, Council approved funds to renew a contract with Bickford Pacific Group to provide state lobbyist services to the City effective October 5, 2008 through October 4, 2009.

The City may terminate this Contract, and Bickford Pacific Group waives any and all claim(s) for damages, effective immediately upon receipt of written notice (or any date specified therein) if for any reason the funding from City, State, and/or federal sources is not appropriated or is withdrawn, limited, or impaired.

ADDENDUM NO. 3

PROFESSIONAL SERVICES AGREEMENT FOR LOBBYING SERVICES BETWEEN THE CITY OF WASILLA AND BICKFORD PACIFIC GROUP

THIS ADDENDUM NO. 3 hereby amends the Agreement to provide Lobbying Services between the City of Wasilla and Bickford Pacific Group dated October 4, 2005, as follows:

SECTION 5. TIME OF PERFORMANCE

The services of the consultant shall commence on October 5, 2008 and shall terminate on October 4, 2009. The period of performance may be extended for additional periods only by the mutual written agreement of the parties.

APPENDIX A. SCOPE OF SERVICES

Bickford Pacific Group shall be responsible for all representation of the City of Wasilla in the State of Alaska and Bickford Pacific Group shall not represent any other municipality in the State of Alaska. This shall include but not be limited to:

- 1. State Appropriations Request including all preparation, submission, and advocacy with assistance from the Mayor and the appropriate City staff. Areas for such request include but are not limited to: Transportation Infrastructure, Water and Sewer Infrastructure, Tourism Development, and Telecommunications Infrastructure.
- 2. Advocacy but not preparation for federal Administrative grants submitted by the City with assistance from the Mayor and appropriate City staff.
 - 3. Monitoring and advocacy on specific bills identified by the Mayor and/or Council.

APPENDIX B. FEE SCHEDULE.

Consultant will be paid a total of \$24,000 for the twelve (12) month period ending October 4, 2008 in the amount of \$6000 per quarter to be billed on December 4, 2008, March 4, 2009, June 4, 2009 and September 4, 2009. Expenses including travel, meal allowance, phone, copying, fax, and any other expenses shall be limited to \$2,000 during the entire period of this agreement.
