Two proposals were received; EmJays Mobile Food Vending (EmJays) and MYHouse. A committee of four scorers (Director of Recreation Services, Event Production & Facility Supervisor, Finance Controller, and the Executive Assistant to the Mayor) scored the proposals based upon approach/methodology, experience, and references. Based upon the criteria, EmJays scored the highest with 238.5 total points (see attached).
