REGULAR MEETING

I. CALL TO ORDER

The regular meeting of the Wasilla Planning Commission was called to order at 6:01 PM on Tuesday, July 11, 2017, in Council Chambers of City Hall, Wasilla, Alaska by Jessica Dean, Chair.

II. ROLL CALL

III. PLEDGE OF ALLEGIANCE

A. Commissioner Brown led the Pledge of Allegiance.

IV. APPROVAL OF AGENDA

GENERAL CONSENT: The agenda was approved as presented.

V. REPORTS

A. City Deputy Administrator

Ms. Carden stated that this is the first year the City has facilitated the parade, handed out some photos, and provided a brief report on the 4th of July festivities. Also, in the month of June there were 59 new or renewed business licenses providing services in City. The Mayor will allow more community input on proposed sales tax increase at the July 24, 2017 City Council meeting. There will be a Centennial event – paint a scarf – on Thursday night at the Museum and on August 5 there will be an all-day fitness fair at Menard Center.

B. City Public Works Director

No report given.

C. City Attorney

Mr. Mead provided follow-up on Starn Trust litigation. The time for the judge to respond for reconsideration has passed, so it has been effectively denied. They have 30 days to appeal decision to Supreme Court.

D. City Planner

Ms. Crawford discussed the Walking Audit and what the consultant's recommendation based on their walk of downtown area may be used for Capital Improvements in fall or to amend Code. She also stated that the City Council will conduct a public hearing regarding the landscape regulations and the site plan exemption for residential detached accessory structures at the July 24, 2017 meeting.

He provided some recommendations on the discussion for the Committee of Whole topics regarding food trucks and farm animals.

Ms. Crawford provided a summary of Land Clearing Waiver #17-05 (Resolution Serial #17-18).

b. Applicant

Ms. Melissa Branch, P.E. Agent and Mr. Mike Bridges, representative for the owners of First National Bank, stated she does not have any objections to the proposed conditions and is here primarily for questions and also provided an aerial section map for Commission to view.

Commission Breese asked whether Mr. Lube agrees to park their vehicles behind the landscape buffer along the road.

Mr. Bridges responded to Commissioner Breese regarding the buffer and that they would like to lease a portion of the paved parking area to Mister Lube. The parking spaces will be facing Mister Lube on the north side of First National Bank's property.

Commissioner Mayer questioned whether Dairy Queen felt this project was interfering with their operations.

Mr. Bridges stated that Dairy Queen is under new ownership and First National Bank has already made an arrangement with them to take back part of the leased parking spaces and are working on converting a section to lease to Mister Lube.

Commissioner Mayer also inquired as to whether the bank would assume all responsibility for vegetation and upkeep.

Mr. Bridges acknowledged that it is the bank's property and their responsibility to maintain.

c. Private person supporting or opposing the proposal. Chair Dean opened the public comment portion of the public hearing.

With no one stepping forward, Chair Dean closed the public comment portion of the public hearing.

MOTION: Commissioner Mayer moved to approve Land Clearing Waiver #17-05 (Resolution Serial #17-18), as presented.

MOTION: Commissioner Brown moved to amend Condition #2 to read as follows:

 Landscaping and vegetation on the site must be installed and maintained in perpetuity as shown on the landscape plan date stamped June 30, 2017, attached as Exhibit A to Resolution Serial No. 17-18, as required in WMC 16.33.060

VOTE: The motion to approve the amendment to strike "date stamped June 30, 2017," as presented, passed unanimously.

VOTE: The motion to approve Land Clearing Waiver #17-05 (Resolution Serial #17-18) as amended, passed unanimously.
