SUMMARY STATEMENT: The Airport Taxiway B project was completed in 2008 with City funds available for the other airport projects. Ordinance Serial No. 09-22 transfers \$10,000 to begin engineering services for the Airport Master Plan leading to Federal Aviation Administration grant requests for 2009-2012. Attached is the current airport capital improvement plan. This ordinance also transfers \$1,000 for match funding to close out the Security Improvements Phase 2 project that was completed this year.

STAFF RECOMMENDATION: To adopt Ordinance Serial No. 09-22 that transfers funds in the amount of \$11,000 for the Airport Master Plan and Security Improvements Phase 2 Project.

CAPITAL IMPROVEMENT PLAN

The following project list provides the City's airport capital improvement plan and describes the projects anticipated for the next 20 years. This plan is updated occasionally to re-prioritize projects to reflect changing conditions and is used to seek FAA funding. The AIP codes for Wasilla projects are: 3-02-0417-XX-20XX. The recommended development plan is divided into three phases which are Near-Term (0 to 5 years), Mid-Term (5 to 10 years), and Long-Term (10 to 20 years) and is summarized in Table 1 below.
