### **Summary Statement:**

The intent surrounding the development of this program is to fill a need for an adult advanced hockey league program requested by the members of the community. This program would fulfill a fiscal year 2017 and 2018, Council Goals and Initiative by encouraging and promoting recreational programs, events, and activities to improve the quality of life of the City's residents through the use of City facilities.

The McDonald Center in Eagle River is currently turning away players due to saturated registrations and will assist by passing those players to the Menard Center. There is currently no advanced hockey league program in the Wasilla or Palmer area.

This program would consist of 2 preseason practices, a 15-game season that would start October 15<sup>th</sup> and run through February 25, 2018, with a tournament scheduled for March 3-4, 2018. All practices and games are on Sundays after 8 p.m., which does not interfere with any other youth, or public activity, and is at a time that is not currently utilized by patrons. No additional staff would be needed. All players are insured under the US Hockey Association. Player fees would be collected for the program. The appropriation requested would pay the referees and jerseys for 4 teams.

It is hopeful, the program will grow each year, and that teams would be sponsored by local businesses offsetting expenses to the program.

With a minimum of 40 players required, but with 80 players anticipated, the following net profit could be realized:

- 4. Menard league would cost each player \$ 13.40 per game (22 hrs). The Brett is \$ 15.22 per game (23 hrs) but no jersey.
