WHEREAS, through the tireless efforts of Curtis D. Menard in directing the steering committee responsible for placing the issue before the voters of Wasilla and the subsequent passage of the referendum; and

WHEREAS, Curtis D. Menard dedicated himself to the Wasilla Community serving on the Matanuska-Susitna School Board, State House of Representatives, State Senate, and as Mayor of the Matanuska-Susitna Borough; and

WHEREAS, Curtis D. Menard remained an ardent supporter and leader of civic, educational and athletic endeavors within the community as well as an advocate of the continued success of the sports center.

NOW, THEREFORE, BE IT RESOLVED, that the Office of the Mayor, with the concurrence of the Wasilla City Council, hereby changes the name of the Wasilla Multi-Use Sports Complex to the Curtis D. Menard Memorial Sports Center.

ADOPTED by the Wasilla City Council on March 23, 2009.

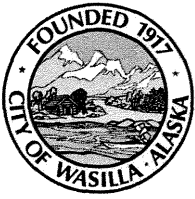
