# **SUMMARY STATEMENT:**

Wasilla High School hosted the 2009 State High School Hockey Tournament in February for both small and large schools. The hosting of this tournament proved to be a great economic boost to the economy of Wasilla. Many hotels, eating establishments and businesses benefited from the team and spectators staying the area.

The Multi-Use Sports Complex saw an overall increase in revenue that week of approximately \$6,650.

To help offset the costs to Wasilla High School, it is respectfully being requested that the cost of the ice rental be reduced by \$4,000 for the year 2010 and retroactively for the year 2009.

ACTION: Reduce the cost of the Multi-Use Sports Complex Ice Rink Rental fee for the 2009 State High School Hockey Tournament by \$4,000 for Wasilla High School for the year 2010 and retroactively for the year 2009.

Below, as you requested, are some revenue numbers associated with the High School Hockey Sate Tournament and also a comparison of revenues during a typical weekend at the Sports Complex.

# State High School Hockey Tournament – February 12, 13, 14, 2009

Ice Rink revenue/rentals	\$5,950.00
Concession revenue	\$3,661.00
Cold drink vending machines	\$1,300.00*

# Typical weekend in February without high school games or Alaska Avalanche games:

Ice Rink revenue/rentals	\$2,910.00
Concession revenue	\$ 700.00**
Cold drink vending machines	\$ 650.00*

- \*The cold drink vending machine revenue is based on a full 7days of revenue.
- \*\*This is an average of concession revenue received for a similar 3 day period when there is no high school or Alaska Avalanche games on the schedule.

A couple of items to note is that when a tournament of the size of the State High School is scheduled in the facility, additional labor as well as janitorial supplies are used.

- Additional labor this year was approximately 15 hours calculated at approximately \$25 per hour or a total of \$375.00.
- Approximate cost of janitorial supplies is \$300.00
