**Section 1. Classification.** This ordinance is of a general and permanent nature and shall become part of the city code.

**Section 2. Amendment of section.** WMC 3.85.010.B, is amended to read as follows:


- B. The following positions are confidential/managerial positions:
1. Chief of police;
  2. Recreational and cultural services manager;
  3. **Finance director**[CHIEF FINANCIAL OFFICER];
  4. Public works director;
  5. Deputy administrator; and
  6. Executive assistant to the mayor.

**Section 3. Effective date.** This ordinance shall take effect upon adoption by the Wasilla City Council.

**SUMMARY STATEMENT:** Ordinance Serial No. 09-43 is to correct a discrepancy in the Wasilla Code. In the Wasilla Municipal Code 2.28.020 the code identifies the Finance Director as the person in charge of the Finance Department. However, in WMC 3.85.010 it refers to the Chief Financial Officer. The intent is to clearly identify the title for this position as Finance Director.
