- 3. **AM No. 09-17:** Award of contract to Tekmate to provide information technology support services to the City of Wasilla.

Ms. Charles:

- noted a technical correction to page 222 of the packet (page 2 of the contract) specifically to section 2(a); and
- stated that the clause should read "ninety (90) days" not "ninety (30) days".

MOTION: Council Member Larson moved to adopt AM No. 09-17.

Discussion ensued.

(Deputy Mayor Holler was excused from the regular meeting at 9:40 p.m.)

- MOTION: Council Member Larson moved a primary amendment to 2(a) of the contract to strike the words "upon said other party's breach of this agreement" to read as follows: This agreement may be terminated by either TekMate or Client upon ninety (90) days prior written notice to the other party.
- VOTE: The primary amendment passed without objection.
- VOTE: The main motion passed without objection.
