SUMMARY STATEMENT: This ordinance amends the FY09 budget by appropriating Alaska Department of Conservation loan funding that is available through the American Recovery and Reinvestment act of 2009 for the Garden Terrace Water Main Project on Abby Blvd. The terms of this loan will include a 90 percent forgiveness provision and a one (1.0) percent interest rate on the original principal amount, resulting in a finance charge of \$5,750. Another Ordinance will be needed in FY2010 to amend the budget to account for the finance charge when the project is complete.
