Summary Statement: The Wasilla City Council adopted Ordinance Serial No. 17-01, January 23, 2017 whereby accepting a five-year and three-month contract from the Matanuska-Susitna Borough for E-911 and dispatch services. When adopted, an appropriation was made for only the

Fiscal Year 2017 with the understanding that each fiscal year thereafter would be appropriated through the normal budget process. The Fiscal Year 2018 Budget was adopted before the acceptance and appropriation for the MSB Dispatch Services contract and as such is being requested now to cover operational needs.

The Wasilla City Council adopted Ordinance Serial No. 17-17 providing for the adoption of the annual budget for Fiscal Year 2018. The adoption of this ordinance provided appropriations for personnel of nine new positions as specified within the dispatch services proposal in the amount of \$994,773. However, since adoption for the annual budget, revised personnel numbers allow a reduction of (\$86,185) to be used for operational funding.

Of the budgeted \$1,302,303 to be received from the MSB contract, \$908,588 is committed for personnel appropriations, leaving an available appropriation of \$393,715.

This ordinance, appropriates \$373,300 to fund operational needs for Fiscal Year 2018 with \$86,185 being moved from personnel services line items and \$271,115 requested to be appropriated from the dispatch services revenue. Additionally, \$20,000 is being requested to fund new computers through the Equipment Replacement Fund.

Staff Recommendation: Introduce and set the ordinance for public hearing Ordinance Serial No. 18-01.
