An Ordinance Of The Wasilla City Council Amending The Fiscal Year 2018 Budget By Appropriating \$6,235 Within The Federal Asset Forfeiture Fund For A Wasilla Police Department Drug Terminator Incinerator.

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. To amend the fiscal year 2018 budget by appropriating funds within the Federal Asset Forfeiture Fund for the purchase of a drug incinerator for the Police Department.

Section 3. Appropriation of Funds. The funds are appropriated to the following:

The ELASTEC Drug Terminator is a portable incinerator for the disposal of evidence drugs, paraphernalia and Active Pharmaceutical Ingredients (APIs). Drugs are safely destroyed by injecting them into a cyclone of fire with our patented Easy-Feed Feed Cartridge.

The ELASTEC Drug Terminator also incinerates other non-hazardous substances such as documents, plants, food, and lab materials with minimal environmental impact. Non-combustibles, such as syringes and sharps, are sterilized and can be disposed in municipal waste.

A more efficient method than open barrel burning, the intense heat creates a clean, smoke-free burn disintegrating the discarded materials into an average of 1% to 3% ash residue. The ELASTEC Drug Terminator assembly is easily moved from one location to another on a dolly-like cart.

The ELASTEC Drug Terminator attaches to a removable head or “open-end” drum as specified by ISO Standards. The measurement of this drum type is standard internationally. ISO 15750, published in 2002, traditionally identifies this drum as being 55 American Gallon.

Law Enforcement Drug Disposal Applications



The ELASTEC Drug Terminator makes it easy for law enforcement agencies to dispose of confiscated drugs and narcotics safely, on-site and on demand.

The controlled destruction of confiscated drugs stored for evidence by law enforcement agencies is mandated by the Uniform Controlled Substances Act and is enforced by the United States Drug Enforcement Administration (DEA). Federal and state hazardous waste rules and regulations, enforced by the United States Environmental Protection Agency (USEPA), must be followed when disposing of impounded drugs.

DEA National Prescription Drug Take-Back Initiative

The United States Drug Enforcement Administration (DEA) Office of Diversion Control periodically initiates a national prescription drug take-back program administered through local and state law enforcement agencies. More information on the DEA's take-back program can be found [here](#).

The Elastec Drug Terminator is a double-duty drug-fighting tool for law enforcement:

- To dispose of confiscated drugs
- To keep illicit prescription medications off the street through sponsored community drug take-back programs.

With state and local budget cuts, some law enforcement agencies are using asset forfeiture funds to offset the costs of managing and disposing of contraband. Many departments have purchased the Elastec Drug Terminator with these funds.

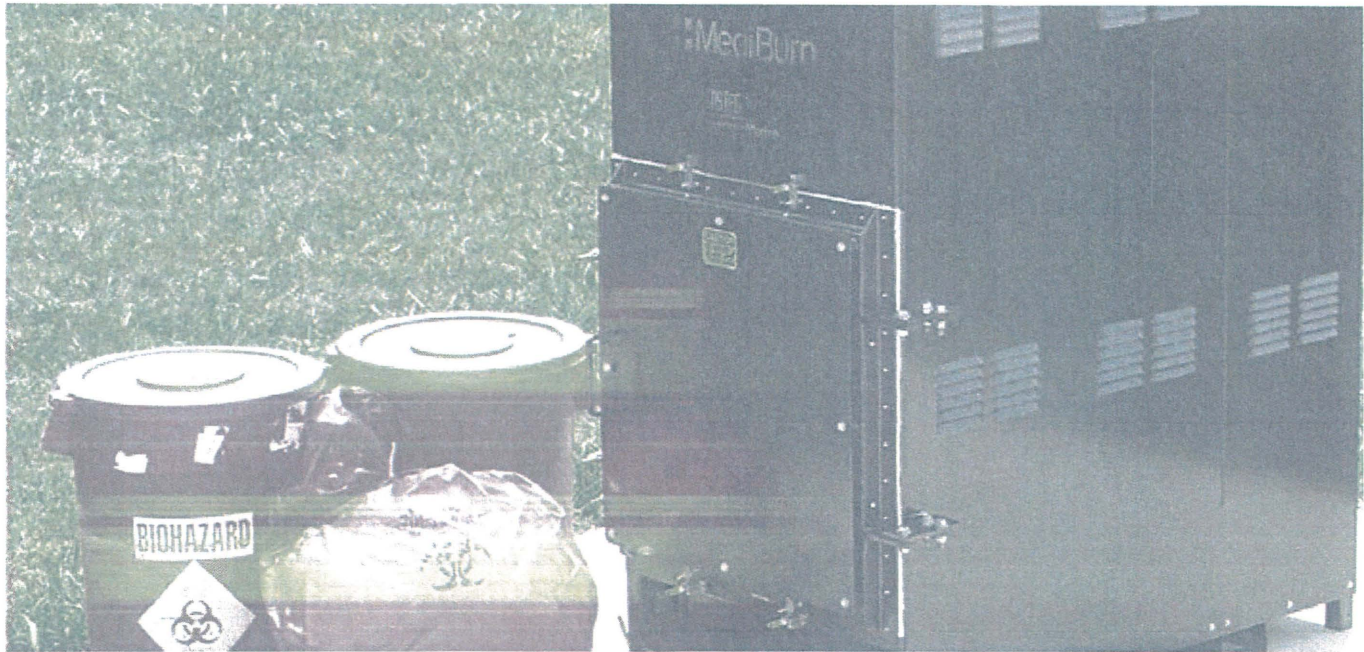
Military Drug Disposal Applications



The ELASTEC Drug Terminator is used in military camp installations, most recently in the Middle East, for confiscated drug destruction and waste disposal. The U.S. Army, U.S. Air Force and the Army Corps of Engineers have purchased the Drug Terminator for use world-wide.

The United States General Services Administration (GSA) regulates the disposal of seized, forfeited, voluntarily abandoned and unclaimed personal property under the custody of any Federal agency located in the United States, the U.S. Virgin Islands, American Samoa, Guam, the Commonwealth of Puerto Rico, the Northern Mariana Islands, the Federated States of Micronesia, the Marshall Islands, and Palau.

Portable Medical Waste Incinerator

In States requiring a two-chamber incinerator, the ELASTEC MediBurn is an option to the barrel-based Drug Terminator to dispose of illicit and expired prescription drugs. The MediBurn has a higher batch-load capacity than the Drug Terminator, and it is completely electronic.

Available in two sizes, the original ELASTEC MediBurn can dispose of up to 8 cubic feet (0.22 cubic meters) of infectious and pathological waste per load with a burn rate of 20 kg per hour. The ELASTEC MediBurn30 can dispose of up to 10.5 cubic feet (.3 cubic meters) of waste per load.

The ELASTEC MediBurn measures just 82 inches (2 meters) by 34 inches (0.9 meters) by 79 inches (2 meters). It is easily installed where electricity or a generator is available, and it can be moved to different locations with minimal effort. The Elastec MediBurn uses relatively little fuel, reducing the burned material to a small pile of ash.

The ELASTEC MediBurn is simple to operate. Set it up, hook it to a generator or electricity, pour in diesel fuel, and it's ready to run. It's a good unit. It's priced right. It does what it's supposed to do. And it can do it pretty much anywhere.

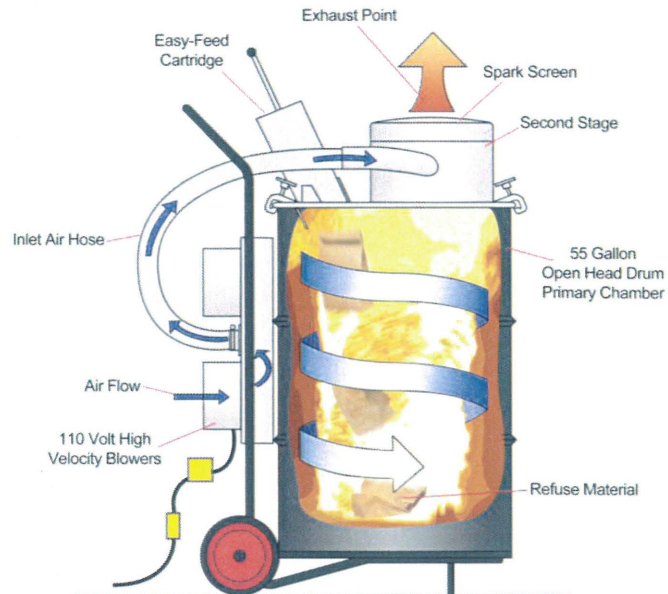

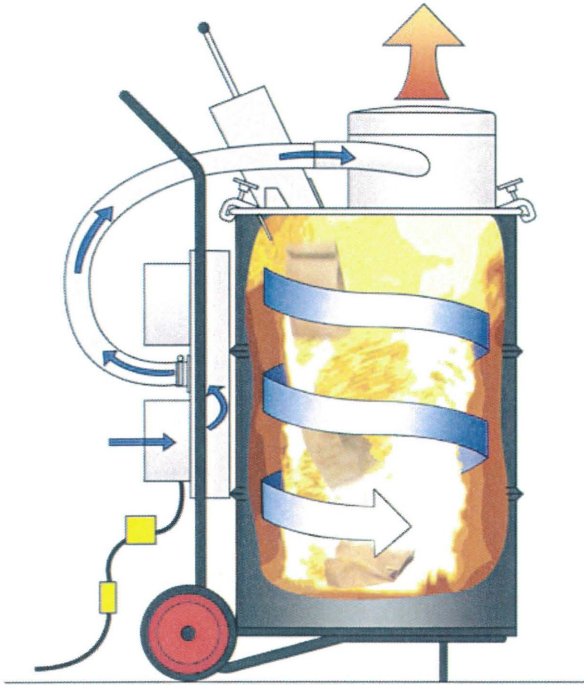

Simple and Safe to Operate.

- Ignite and wait for the fire to start.
- Plug in the ELASTEC Drug Terminator to a 120 (or 220) volt outlet.
- Clamp the ELASTEC Drug Terminator lid onto the barrel.
- Load the Easy-Feed Cartridge with drugs and paraphernalia.
- Inject into the ELASTEC Drug Terminator lid.
