SUMMARY STATEMENT: In accordance with WMC 5.08.120, on May 1, 2006, the City of Wasilla issued Request for Proposal 0612-02006/WM for banking services. AM No. 06-28 was approved by Council on June 12, 2006 authorizing the award of a three-year contract with (2) additional one (1) year terms for banking services to Wells Fargo. The contract became effective August 1, 2006 and the three-year term will expire July 31, 2009.

Other than the "Custody \$ Safekeeping Fees" and "Merchant Services Fees" for Visa, the \$7,650 for Banking Service Fees are offset by a \$140,000 minimum balance

required to be deposited. The estimated annual costs are based upon current volume for Custody and Safe Keeping \$3,510, and Merchant Services Fees \$10,150.

STAFF RECOMMENDATION: Council is requested to authorize the extension of the three-year contract by exercising the first one (1) year extension. By authorizing this extension, the contract would terminate on July 31, 2010. The continuation of the contract is subject to and contingent upon sufficient funds being appropriated, budgeted, and otherwise made available by the Wasilla City Council. The City may terminate this Contract, and Wells Fargo waives any and all claims(s) for damages, effective immediately upon receipt of written notice (or any date specified therein) if for any reason the funding from the City, State, and/or Federal sources is not appropriated or is withdrawn, limited, or impaired.
