Ordinance Serial No. 18-14**

An Ordinance Of The Wasilla City Council Amending Wasilla Municipal Code Section 2.04.035, Compensation And Reimbursement; And Section 2.60.010, Establishment, Duties And Compensation, To Revise The Rate Of Pay For The City Council And Planning Commission.

Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.

Section 2. Amendment of subsection. WMC 2.04.035(A), within Compensation and reimbursement, is hereby amended to read as follows:

A. Council members shall be compensated **as follows:**

1. Regular Meetings. ~~T~~two hundred twenty-five dollars (\$225.00) for each regular meeting attended.

2. Special Meetings. **One hundred twelve dollars and fifty cents (\$112.50) for each special meeting attended. Payment shall not be made for more than eight special meetings per fiscal year, nor will payment be made for special meetings lasting less than one hour.**


Section 3. Amendment of subsection. WMC 2.60.010(C), within Establishment, duties and compensation, is hereby amended to read as follows:

C. ~~The compensation of~~ Each commission member shall be paid a flat rate of one hundred twenty-five dollars (\$125) per month provided the commissioner attends at least one regular planning commission meeting per month ~~seventy-five dollars (\$75.00) per meeting attended.~~

Section 4. Effective date. This ordinance shall take effect on July 1, 2018.

Summary Statement: Currently, council members receive \$225.00 for each regular meeting attended; however, they are not paid for attending special meetings. On average, five special meetings take place each fiscal year.

Ordinance Serial No. 18-14, seeks to establish that council members will be paid \$112.50 for each special meeting attended (**maximum of eight**), provided the meeting lasts an hour or more.

No compensation will be received for more than eight special meetings attended or those lasting less than an hour.

The ordinance also seeks to increase the rate of pay for planning commissioners from \$75.00 per meeting attended, to a flat rate of \$125.00, per month, provided the commissioner attends at least one regular planning commission meeting per month.

The proposed effective date of the ordinance is July 1, 2018 (fiscal year 2019).

Staff Recommendation: Introduce and set the ordinance for public hearing.
