Thank you for giving Alder Architecture & Design (AAD) and our Engineering team this opportunity to present this proposal.

#### Scope of Work

#### This new facility is described as follows:

- A Storage Building at Menard Sports Center for the City of Wasilla
- Approximately 1500 sq. ft. 2000 sq. ft, assumed per an estimated s.f. cost based on your budget number given
- One big open area, no toilet room or office
- Description provided:
  - o Storage building at the Menard Center, to replace a series of connexs
  - Budget is \$310,000
  - o COW will do the survey and land use permit, and have survey for Fire Marshall review
  - Scope is to design and obtain Matsu Fire Marshal permit and provide bid ready documents for the building
  - The City will provide CA services and distribute the Bid Package
  - Need structural design for the concrete foundation design (the city can excavate a test hole), and wood framing
  - (1) Overhead door and (1) man door
  - o 12-16 foot wall plate height
  - o Metal Siding to match Menard Center
  - o Electrical Service
  - Natural gas unit heaters
- No vehicle maintenance or hazardous material storage that require special code provisions
- No bidding or CA services included.

This proposal is being submitted based on information provided by Plans North and the following Scope of Work:

  - Heating will consist of a natural gas fired unit heaters.
  - There is no ventilation or plumbing requirements for the building since its use is limited to storage and will not involve any vehicle maintenance
- Electrical Scope Construction Documents (Q Engineers, Inc.)
  - The building will be equipped with a new electrical service or can be sub-fed by the nearby building, depending on owner preference.
  - o Coordination with the utility company or the nearby building is included in this effort.
  - Interior lighting will be provided with high-efficient LED fixtures.
  - o LED exterior lighting will be provided at the personnel and overhead doors.
  - General purpose receptacles will be provided in the building to meet the owner requirements.
  - Exit and emergency lighting will be provided as required by Code.
  - No data or fire alarm systems are included, nor believed to be required for the building.
- All specifications are sheet specs.
- Coordination and resolution of comments generated by regulatory agencies such as the City, State and utility companies.
- Initial kick off meeting on site for entire team to review site and existing conditions
- 2 weeks to complete 60% documents for owner review
- Receive owner comments within 2 weeks
- Final drawings to be completed within 2 weeks from owner comments
- This proposal assumes overall design effort will be completed within 60 days of NTP. Additional time beyond this period may result in additional fees.
- (2) Large format (22x34) Final drawings will be provided for this contract to the City and (1) to the Fire Marshal as the review set.
- All expenses with phone calls or mailings are covered under this fee proposal.
- Any 8 ½"x11" or 11"x17" printing required for this project. Any large format printing required will be billed directly to the owner on invoicing.
- Final Deliverables: PDF in 11x17 and 22x34 and any printing as described above.
- All drawings will be signed and sealed by the Architect and all Engineers.

Any responses and coordination needed directly with the Fire Marshal to obtain the permit will . be covered by this contract.

## Not included in the Scope of Work of this contract:

- Any other disciplines such as Civil, Geotechnical or Environmental engineers.
- Additional requested Large Format printing will be invoiced to the owner as an expense.
- Construction administration or submittal reviews. However, clarifications of drawings will always be provided and addressed with any contractors as needed.
- No additional site visits have been included in our fees beyond the initial visit. .
- The building will not require any plumbing or ventilation. There will be no maintenance or . running of vehicles inside the building. There will be no stored materials that might require explosion-proof electrical equipment.
- This proposal is for a single, fast track design, and includes one review. Design will proceed after • receiving a final floor plan, as-builts drawings of existing systems and final equipment specifications. This fast track scope will allow us to produce drawings as quickly and costeffectively as possible. Additional fees may apply if more than one review is requested.
- City of Wasilla 3% sales tax is exempt for the City.
