**Section 3. Appropriation.** The funds are appropriated to the following:



**SUMMARY STATEMENT:** The Library has received a Continuing Education grant from the Alaska State Library, which used federal monies provided by the Institute for Museum and Library Services. This is a reimbursement grant; the City was required to pay the costs up front and then apply for a reimbursement up to \$1,000. These monies will be used to reimburse the City for \$1000 of the registration and travel costs for the Youth Services Librarian to attend the 2009 Alaska Library Association Conference in Kodiak, Alaska.
