
- 1) See revised sheet C-101 highlighted areas to be <u>deleted/amended</u>:
  - a) <u>Delete</u> perimeter sidewalks.
  - b) <u>Delete</u> aggregate mulch.
  - c) <u>Delete</u> outer row of concrete panels and corresponding concrete slab. Construct concrete slab 4 feet beyond inner row of panels. All engraved granite panels to be installed on inner row of concrete panels.
  - d) <u>Delete</u> three (3) benches.
  - e) Deleted areas to be top-soiled and seeded to match adjacent areas.
  - f) Use <sup>3</sup>/<sub>4</sub>-inch minus crushed rock for aggregate mulch along center sidewalk.
- 2) See revised sheet G-200: <u>Delete</u> the removal of existing AC pavement (highlighted).
- 3) See revised sheet G-301: <u>Delete</u> concrete wheel stops (highlighted).


