## CITY OF WASILLA **RESOLUTION SERIAL NO. 09-18**

A RESOLUTION OF THE WASILLA CITY COUNCIL SUPPORTING ALASKA'S VETERANS, CONSUMERS, AND SMALL BUSINESSES BY OPPOSING THE MEDICAL DEVICE SAFETY ACT OF 2009, PROPOSED IN THE U.S. SENATE AS S.540 AND IN THE U.S. HOUSE AS H.R.1346.

WHEREAS, the Medical Device Safety Act of 2009 seeks to undo the protection from lawsuits granted to medical device inventors when they have already passed federal regulatory guidelines and testing set forth under the Food and Drug Administration; and

WHEREAS, the federal government should protect the inventors and designers of new, life-saving and federally approved medical devices; and

WHEREAS, the flood of lawsuits that would follow the passage of such a harmful law would likely lead to the shutdown of hundreds of small businesses dedicated to the design of medical devices and stifle innovation; and

WHEREAS, our military veterans deserve the finest, modern medical devices and technologies when they return home from Iraq and Afghanistan, such as motorized prosthetics, heart stents, pacemakers, and reconstructive surgery; and

WHEREAS, Wasilla is also home to hundreds of veterans of military operations in Somalia, Kosovo, Vietnam, Korea and World War II who also depend on these lifebettering medical devices as they grow older; and

WHEREAS, the Medical Device Safety Act of 2009 is opposed by groups large and small, including the Mat-Su Veterans Council, Vietnam Veterans of America Alaska Chapter, the Alaska Veterans Business Alliance, the Alaska Council of Veterans. Vietnam Veterans of America National Chapter, and the United States Chamber of Commerce.

NOW, THEREFORE, BE IT RESOLVED, to protect Alaskan veterans, consumers, and small businesses, the City of Wasilla opposes the Medical Device Safety Act of 2009.

BE IT FURTHER RESOLVED that this resolution shall be forwarded to Senator Lisa Murkowski, Senator Mark Begich, and Representative Don Young.
