last five words in the header to read as follows:

A RESOLUTION OF THE WASILLA PLANNING COMMISSION APPROVING USE PERMIT NUMBER 18-03 TO OPERATE A COMMERCIAL BOARDING KENNEL WITH NO MORE THAN 30 DOGS AND SIX CATS WITH GROOMING SERVICES PROVIDED TO THE

**BOARDED ANIMALS.** 

VOTE: The motion to amend the main motion passed unanimously

MOTION: Commissioner Bushnell moved to amend the main motion to remove in

condition #11, line 5, the word "conditional" and to read as follows:

1. Construction on the site must substantially comply with the site plan, landscape plan, and building/elevation drawings date stamped June 14, 2018, attached as Exhibit B to Resolution Serial No. 18-10. Any changes to the site plan must be submitted to the City Planner for review. Substantial modifications will require submittal of an amended conditional use permit application, including application fee and Planning Commission review and approval.

VOTE: The motion to amend the main motion passed unanimously.

VOTE: The motion to approve elevated use permit #A18-03 (Reso. #18-10), as

amended with Commissioner Brown, Bushnell, Dean, Mayer in favor and

Commissioner Breese opposed.

Mr. Swanson asked for clarification regarding the number of dogs approved with the permit.

Mr. Richter stated that as a Planning Commission they missed asking an important question of the applicant and that is why would you want to buy a piece of property in a residential neighborhood and build a commercial kennel that the neighbors would hate.

Mr. Wayne Whaley stated his personal opinion about having a property developed instead of leaving the property vacant and used as a junk yard.

Mr. Brian Bess stated his disappointment about the Planning Commission decision.

Ms. Marcie Lyman stated that she appreciates the Commissioners' time and stated that she believes the vote was not consistent with the super majority language in the code.

#### 9. STAFF COMMENTS

Mr. Crawford provided information on the Summer Block Party - Sudsy Slim Brews Again that was held on July 28, 2018 at the City Museum site. She stated that there were approximately 13 food trucks and 28 vendors, which made it a successful event. She also reported that the Planning Department had 62 people stop by the Planning booth and complete a survey regarding whether food trucks should be allowed within the city limits. The results of the survey will be provided to the Planning Commission at a future meeting.
