**Summary Statement:** This contract award is in response to the City's Request for Proposal No. 0524-0-2018/AG for architectural and engineering services to design and oversee construction of the new Wasilla Police Station. The City received 9 proposals and they were reviewed by an evaluation committee that advanced the top three proposals to an interview round of scoring.
